

謝謝閣下 6 月 23 日的來函，轉傳張宇人議員就警方在卡拉 OK 場所檢取物品一事的文件。現就文件所提出的意見回覆如下，煩請轉告委員會。

- (一) 警方在搜查卡拉 OK 場所時，如發現有違例事項，會採取適當的行動搜集證物，用以輔助調查及檢控。在檢取物件前，警方會先衡量物件的證據價值，才決定是否予以檢取。
- (二) 除可於卡拉 OK 場所檢走物件外，警方亦會考慮以攝影方式記錄物件資料，但必須視乎每一案件的個別情況，以決定處理相關物件的方法。

Legislative Council Panel on Security

Thank you for your letter of 23 June, forwarding a note from Hon Tommy CHEUNG Yu-yan regarding the seizure of property from karaoke establishments by the Police. I should be grateful if you could relay our views, as set out below, to the Panel.

- (a) When breaches of the relevant laws are found by the Police during their search of karaoke establishments, appropriate actions will be taken to gather evidence to assist in investigation and prosecution. Before seizure of any properties, the Police will first consider the evidential value of the relevant properties before taking the necessary action in this regard.
- (b) Besides seizure of properties from karaoke establishments, the Police will also consider recording details of the properties by camera. The procedures of handling relevant materials will depend on the circumstances of individual cases.
