A 'war cabinet' known as the daily SARS Round Up meeting, formed by the HA Chief Executive, Directors and Cluster Chief Executives and often with the participation of the HA Chairman, served as a dynamic command unit that met daily to appraise the rapidly changing situation, share experience amongst clusters and make strategic decisions.

2. Details of authorization given to the acting Chief Executive appointed by HA.

Dr KO Wing Man was authorized by the HA Chairman to deputise for the Chief Executive during Dr HO's absence with effect from 24 March 2003 (Attachment 1 refers).

This deputizing arrangement for the Chief Executive position had always been the same. Dr KO had previously on many occasions deputised for the Chief Executive during his absence (Attachment 2 provides examples). This authority to approve deputising appointments for the Chief Executive was delegated by the HA Board to its Chairman on 29 July 1997 (Attachment 3 refers).

3. The role of Dr HO while the acting Chief Executive was discharging his duties.

Dr HO did not play a formal role while the deputising Chief Executive was discharging his duties. During the whole period, Dr KO chaired the formal daily SARS Round Up meetings. Rather, as his health allowed, Dr HO contributed ideas and insights to the 'war cabinet' via video conferencing, which the team appreciated as helpful during times when everybody was under great stress.






