#### I. Election of Chairman and late membership

Mr NG Leung-sing was elected Chairman of the Bills Committee.

- 2. <u>Members</u> agreed that the requests of Mr CHEUNG Yu-yan and Mr WONG Sing-chi for joining the Bills Committee after the deadline of 10 December 2003 be acceded to.
- 3. <u>Mr Eric LI</u> declared interest as the President of the Hong Kong Sports Association for the Mentally Handicapped.

### II. Meeting with the Administration

4. The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 5. The Bills Committee requested the Administration to provide the following information -
  - (a) the number of staff of the Leisure and Cultural Services Department to be redeployed for coping with the additional workload arising from the dissolution of the Hong Kong Sports Development Board (SDB);
  - (b) the savings in staff costs arising from the dissolution of SDB and the estimated additional resources to be allocated to the reconstituted Hong Kong Sports Institute (HKSI) under the new administrative structure for sport; and
  - (c) the establishment and salary ranges for individuals posts in SDB and the reconstituted HKSI, and the salary ranges of similar posts in the labour market.
- 6. The Administration undertook to provide members with its analysis of views on the dissolution of SDB in 380 submissions received in its public consultation exercise in the Sports Policy Review.
- 7. <u>Mr Andrew CHENG</u> said that the Democratic Party would oppose the dissolution of SDB, unless the Administration could provide convincing grounds that the new administrative structure for sport would be better than the existing one.

#### III. Any other business

8. <u>Mr LEE Cheuk-yan</u> moved the following motion -

"基於草案審議委員會不同意政府未有合理解決康體局員工有關過渡安排問題而提交草案,本委員會決議在未解決上述問題前不應就條例進行審議"

The motion was seconded by Miss CHAN Yuen-han, Mr Andrew CHENG and Ms LI Fung-ying.

9. In explaining his motion, <u>Mr LEE Cheuk-yan</u> said that the Bills Committee would continue the discussion on the Bill only after the Administration had resolved the dispute with the staff of SDB over their employment upon the dissolution of SDB. The next meeting would be scheduled as soon as the Administration was ready to revert to the Bills Committee.

- 10. <u>Members</u> discussed and voted on the motion moved by Mr LEE Cheuk-yan. Eight members voted in favour of the motion, while four members voted against. <u>The Chairman</u> declared that the motion was passed.
- 11. The meeting ended at 10:50 am.
