NOTE FOR FINANCE COMMITTEE

Report on Redeployment of Funds in One-line Vote Departments

With effect from the 2003-04 Estimates, the one-line vote financial control arrangement has been extended to all bureaux, branches and departments covering 83 heads of expenditure. Under this arrangement, other than specified exceptions, Controlling Officers are given flexibility in meeting all their operational expenditure from approved funds under a single Subhead 000 Operational expenses. This is intended to facilitate the achievement of greater efficiency and enhanced productivity.

- 2. For the purpose of assuring Members on disclosure of information and accountability, in the annual Estimates Controlling Officers operating the one-line vote have been providing an analysis by conventional subheads of components in their operational expenditure. The Administration will continue to provide to Finance Committee with quarterly reports showing actual spending and any redeployment of funds between these components. However, to save paper we only include in this report bureaux, branches and departments that have redeployed funds between the components under Subhead 000 Operational expenses during this quarter. We informed Members of this arrangement in the fourth quarter report of 2002-03 in June.
