NOTE FOR FINANCE COMMITTEE

Changes to the Approved Estimates of Expenditure Approved under Delegated Powers

In accordance with the Public Finance Ordinance section 8(8)(a), the Financial Secretary shall at the end of each quarter of the financial year or as soon as practicable thereafter report to the Finance Committee changes made to the approved estimates of expenditure in that quarter upon approval by him or by any public officer pursuant to a delegation under section 8(3) or (4). This note contains details of such changes made during the second quarter of 2003-04.

2. During the second quarter of 2003-04, 31 applications for supplementary provision, one application for increases in commitments, 15 applications for new commitments, 12 applications for commitments revoted and a net decrease of 863 posts, as detailed in the Report at the Enclosure, were approved under delegated powers.

3. The total additional funds required in the 31 applications for supplementary provision amounted to \$1,662,931,000. A breakdown is as follows -

(1) Head 166 Subhead 661

The supplementary provision of \$1,366,000 was mainly due to the additional requirements for the procurement of a voice recording system and installation of modulating dampers for the air handling units at the Government Flying Service headquarters building.

(2) Head 59 Subhead 661

The supplementary provision of \$2,177,000 was mainly due to the additional requirements for replacement of minor equipment.

(3) Head 168 Subhead 661

The supplementary provision of \$1,850,000 was mainly for the purchase of a standby scanner for backup purpose and for enhancement of the timing system.

(4) Head 70 Subhead 661

The supplementary provision of \$7,489,000 was mainly due to the additional requirement for the implementation of Expeditious Immigration Clearance System at control points.
