政府可否告知本會：

- (一) 是否知悉香港賽馬會足球博彩有限公司每次增加足球博彩的博彩方法後，參與該公司的博彩活動的 18 至 25 歲青少年的數目，以及人數有沒有較之前有所增加；
- (二) 是否知悉該公司自營辦足球博彩活動以來，採取了甚麼措施禁止 18 歲以下青少年參與有關活動，包括抽查投注人士的身份證明文件和核對透過電子途徑投注人士的資料等；若有，因這些措施而被禁止參與有關活動的人數；及
- (三) 當局有沒有調查學生參與足球博彩活動的情況；若有，調查的結果？

(4) Hon WONG Sing-chi (Oral Reply)

Will the Government inform this Council:

- (a) whether it knows the number of young people aged between 18 and 25 who participate in football betting activities each time new betting methods are introduced by the Hong Kong Jockey Club Football Betting Limited, and whether there is an upward trend in such numbers;
- (b) of the measures that have been taken by the company since its operation of football betting activities, to prevent young people aged below 18 from engaging in such activities, including random checks of bettors' proof of identity and verification of the particulars of bettors placing bets through electronic means, etc; if so, of the number of persons prohibited from engaging in such activities as a result of these measures; and
- (c) whether the authorities have conducted surveys on students' participation in football betting activities; if so, of the survey results?
