#(4) 蔡素玉議員 (口頭答覆)

中央人民政府已決定《聯合國氣候變化框架公約》(簡稱 "《公約》")於本年5月5日起適用於香港,而該公約的《京都議定書》(簡稱 "《議定書》")在生效後亦將適用於香港;兩者的目的是減低全球溫室氣體的排放量。就此,政府可否告知本會,有否擬備措施以落實《公約》及《議定書》;若有,請告知詳情;若沒有,原因是甚麼?

The Central People's Government has decided to apply the United Nations Framework Convention on Climate Change ("UNFCCC") to Hong Kong with effect from 5 May this year and the Kyoto Protocol under UNFCCC will be applicable to Hong Kong when it comes into operation. Both instruments seek to reduce global emissions of greenhouse gas. In this connection, will the Government inform this Council whether it has formulated measures to implement UNFCCC and the Kyoto Protocol; if so, of the relevant details; if not, the reasons for that?
