- 2. The Subcommittee deliberated (index of proceedings attached at **Annex A**).
- 3. The Subcommittee noted the Administration's explanation that in order to enhance the safety on public light buses (PLBs), the Road Traffic (Construction and Maintenance of Vehicles) (Amendment) (No. 2) Regulation 2002 and the Road Traffic (Safety Equipment) (Amendment) Regulation 2002 (the Amendment Regulations) were enacted to extend the seat belt legislation to the rear seats of newly registered PLBs and to provide for the installation of high back seats on these PLBs. The proposed resolution was made as a consequential amendment to reflect the change in responsibility of wearing seat belts on PLBs from the driver to the passengers as provided in the Road Traffic (Safety Equipment) (Amendment) Regulation 2002. In this connection, the Subcommittee noted that the Administration's intention was to bring the Amendment Regulations into operation on 1 August 2004.
- 4. <u>The Subcommittee</u> supported in principle the extension of the seat belt legislation to enhance PLB safety, and had no objection to the proposed resolution. Having completed its deliberation, the <u>Subcommittee</u> would report to the House Committee on 21 May 2004 recommending that the Administration could move the proposed resolution in the Council.
