 - (b) to consider reviewing UNSO;
 - (c) to provide further justifications regarding its view that it was inappropriate to disclose CPG's instruction; and
 - (d) to provide, for each regulation referred to in Annex B to the Administration's response to issues raised at the meeting on 20 February 2004, the date when the relevant instruction was received from CPG, the date when the relevant regulation came into force, and how the instruction was implemented in the period between the two dates.
- 3. The Subcommittee agreed to seek the views of Professor Yash GHAI on the United Nations Sanctions (Liberia) Regulation 2003, in particular the constitutional issues arising from the existing arrangements for implementing UNSCRs in relation to sanctions in Hong Kong, and whether and how UNSO should be amended.

- 5. The Subcommittee agreed that an interim report on its work would be made to the House Committee at its meeting on 21 May 2004.
