#### I. Election of Chairman

Mr HUI Cheung-ching was elected Chairman of the Subcommittee.

## Membership

2. <u>The Chairman</u> agreed to accept the late membership of Mr CHEUNG Mankwong in accordance with House Rule 23(a). <u>The Subcommittee</u> further agreed to accept the late membership of Ms Emily LAU in accordance with House Rule 23(b).

#### II. Meeting with the Administration

(Legislative Council Brief issued by the Registration and Electoral Office in December 2003; LC Paper Nos. CB(2)877/03-04(02) and LS27/03-04)

Particulars Relating to Candidates on Ballot Papers (Legislative Council) Regulation

- 3. The Subcommittee deliberated (index of proceedings attached at Annex.)
- 4. <u>Members</u> agreed that the Chairman should move a motion at the Council Meeting on 14 January 2004 to extend the scrutiny period of the Regulation to 4 February 2004.
- 5. <u>Members</u> made the following comments -

#### On the Regulation

- (a) the cut-off dates for application for registration of name/emblem (1 March 2004 and 15 March in subsequent years) were considered to be too early and should be extended;
- (b) a sole candidate on a nomination list should be allowed to print on a ballot paper three names/emblems;
- (c) the permitted descriptions "Independent Candidate" and "Non-affiliated Candidate" on the ballot paper would cause confusion to electors. The Administration should adopt the more commonly acceptable term;

### On the design of the ballot paper

- (d) candidates on the same list should be allowed the flexibility to decide on the size or format of the photograph(s), subject to the space permitted on the ballot paper;
- (e) a few options on the design of photographs to be printed on the ballot paper could be prepared for candidates to consider;
- (f) the ballot paper should not be confined to A3 size, so as to allow flexibility for improvements to be made to the design of the ballot paper;
- (g) if there was only one candidate on a nomination list, the print size of the name/emblem, etc could be made larger;
- (h) there should be clear indication on the ballot paper as to which prescribed bodies appearing on a nomination list were in support of which candidates; and
- (i) any prescribed body on a nomination list should support all the candidates on the list.
- 6. <u>The Administration</u> clarified that the Regulation under scrutiny aimed to provide a legal basis for the printing of specified particulars relating to candidates running for the Legislative Council (LegCo) elections on ballot papers. The sample design of the ballot paper was provided for Members' reference. Subject to the passing of the Regulation, the Electoral Affairs Commission (EAC) would finalize

design of the ballot paper, which would be subject to LegCo's negative vetting under the EAC (Electoral Procedure) (LegCo) Regulation.

7. <u>The Administration</u> was requested to provide a written response to the comments made by members for consideration of the Subcommittee at the next meeting.
