#### I. Meeting with the Administration

(LC Paper Nos. CB(2)1221/03-04(01) - (02), 1197/03-04(01) and 1167/03-04(01))

Electoral Affairs Commission (Financial Assistance for Legislative Council Elections (Application and Payment Procedure) Regulation

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

Suggestions/views of members

- 2. The Administration was requested to consider the following suggestions/views of members -
  - (a) Some members considered that the auditing fee could be out of proportion to the payment some candidates received under the Financial Assistance Scheme (the Scheme), especially in the case of the smaller functional constituencies. Mr CHEUNG Man-kwong considered that the requirement of an auditor's report was unnecessary. Mr Howard YOUNG suggested that the auditor's report should only be required for a claim above a certain amount of financial assistance;
  - (b) Ms Emily LAU considered that as the auditing fee was an expense incidental to the election, it should be regarded as an election expense. She requested the Administration to review the definition of "election expenses" in section 2 of the Elections (Corrupt and Illegal Conduct) Ordinance (ECICO) to take account of the introduction of the Scheme; and

#### Action

(c) Ms Emily LAU requested the Administration to conduct a review on the Scheme in due course, taking into consideration the policies and principles which underpinned the Scheme. She pointed out that while political parties would provide financial sponsorship to candidates, they would also try to maximize the chance for candidates to claim financial assistance under the Scheme. However, according to sections 60D and 60E of LCO, when calculating the amount of financial assistance payable to a candidate, any election expense incurred by the candidate had to be net of any election donation received by the candidate. In the circumstances, the Scheme failed to achieve its intended aim, i.e. its implementation would be conducive to the development of political parties and political groups in Hong Kong.

#### Follow-up action

- 3. The Administration was requested to -
  - (a) advise whether an elected candidate could receive a donation to meet the expenses incurred for the auditor's report, which was not regarded as an election expense, and whether in accepting the donation, the candidate would commit an offence under section 4 of the Prevention of Bribery Ordinance;
  - (b) consider promulgating guidelines clarifying the status of loans involving conditional repayment terms and the status of conditional donations made by political parties to candidates, in order to facilitate compliance with the Scheme;
  - (c) advise whether a candidate was allowed to receive any financial benefit from a political party in respect of any of his election expenses after the candidate had received payment of financial assistance from the Government, without affecting such payment;
  - (d) provide information on the financial assistance schemes for candidates in Canada and Germany, in particular, whether donations received by candidates should have a bearing on the amount of financial assistance payable to candidates; and
  - (e) provide a copy of the relevant electoral guidelines in relation to declaration of interests on loans in an election return.
