#### I. Meeting with the Administration

Electoral Affairs Commission (Electoral Procedure) (Legislative Council) (Amendment) Regulation 2004 (the Amendment Regulation) (LC Paper No. CB(2)2912/03-04(01))

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**). <u>The Subcommittee</u> completed scrutiny of the draft Resolution.

Prevention of the use of camera-equipped mobile telephones in voting compartments and increase of penalty under sections 45 and 96 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (the Regulation)

- 2. <u>Members</u> supported the Administration's following proposals -
  - (a) not to further pursue the proposal to make leaving mobile telephones switched on inside polling stations an offence. The Electoral Affairs Commission (EAC) would implement administrative measures to encourage electors to switch off their mobile telephones inside polling stations; and
  - (b) to maintain its previous proposal to increase the imprisonment term from 3 months to 6 months for offences under section 45(2) (i.e. filming, taking photographs or making any audio or video recording within a polling station without express permission) and section 96 (relating to

protection of secrecy of votes) of the Regulation. However, the imprisonment term for offences under section 45(1) (i.e. communicating with an elector or using mobile telephones or other devices for electronic communication within a polling station contrary to the direction of the Presiding Officer not to do so) would remain unchanged, i.e. 3 months.

Recounting arrangements for Geographical Constituencies (GCs)

3. <u>Members</u> had no objection to the Administration's proposal to provide an additional mechanism for candidates to request a recount of the votes in all counting stations within a GC before the counting results in respect of the misplaced GC ballot papers (if any) were available.

Decentralized counting arrangements for GCs

- 4. <u>The Deputy Chairman</u> reiterated his objection to the Administration's proposal to raise the "200 electors" threshold to only "500 electors" for the purpose of defining small polling stations, where ballot papers cast would be delivered to a main counting station and mixed with the ballot papers of the main counting station before the votes were counted.
- 5. In response to the Deputy Chairman, the Administration said that the estimated number of polling stations which had less than 3,000 electors was 120. The proposal to increase the threshold to "3,000 electors" might incur additional cost for transportation of ballot papers from small polling stations to the main counting station. The Deputy Chairman was of the view that as compared with the original counting arrangements adopted in the 2000 Legislative Council election, the proposal might not have charging effect. The Administration advised that in line with the usual practice, it would give comments as to whether a proposed amendment had charging effect after it had seen the wording of the proposed amendment.

Proposed amendments to the Amendment Regulation

- 6. <u>The Subcommittee</u> supported the Amendment Regulation and the draft Resolution, subject to the Administration agreeing with the Subcommittee's legal adviser on its latest proposed amendments.
- 7. <u>The Deputy Chairman</u> said that he would report the deliberation of the Subcommittee to the House Committee on 25 June 2004. The deadline for giving notice of amendments was 29 June 2004.
