# Information Note for the Legislative Council Panel on Commerce and Industry

Import and Export Ordinance
(Amendment of Schedules 2 and 3) Notice 2003
Dutiable Commodities Ordinance
(Amendment of Schedules 1A and 1B) Notice 2003

## **Purpose**

This paper informs Members of the making of the two captioned Notices by the Secretary for Commerce, Industry and Technology under the Import and Export Ordinance (Cap.60) and the Dutiable Commodities Ordinance (Cap. 109) to add Global e-Trading Services Limited to the list of specified electronic service providers.

## **Background**

- 2. To promote electronic commerce, the Government has introduced electronic services for the submission of a number of official trade-related documents<sup>1</sup> by the trading community since 1997. At present, the trading community is required to submit these documents through a franchised electronic service provider, the Tradelink Electronic Commerce Limited ("Tradelink").
- In anticipation of the expiry of Tradelink's exclusive franchise to provide the concerned electronic services by end 2003, and with the support of the Legislative Council Panel on Commerce and Industry, the Administration launched an open tender exercise in 2002 with a view to appointing additional providers of the electronic services. As reported in the Administration's briefing to the Panel on 14 April 2003, we signed an agreement with Global e-Trading Services Limited appointing the latter as an additional electronic service provider

The documents include restrained textiles export licence, import and export declaration, production notification, certificate of origin, dutiable commodities permit, cargo manifest (excluding road mode of transport) and textiles notification under the Textiles Trader Registration Scheme.

(including the provision of Electronic Trading Access Service ("ETAS")<sup>2</sup>) for import and export declarations and dutiable commodities permits. The appointment is valid for five years with effect from 1 January 2004 and is extendable for two years at the Administration's discretion.

4. The relevant legislation which governs the administration of import and export declarations and dutiable commodities permits provides for the listing of the electronic service providers in Schedules (see Annex 1). This is to ensure a sound legal basis for the status of the service providers, and to govern that an ETAS provider should not send information on behalf of any person unless it has obtained from the person concerned an authorization in writing to do so. These Schedules may be amended by the Secretary for Commerce, Industry and Technology by notice published in the Gazette.

#### **Amendment Notices**

- 5. To tie in with the launching of services by Global e-Trading Services Limited starting from January 2004, we need to add the company to the relevant Schedules. The Secretary for Commerce, Industry and Technology has therefore made:
  - (a) the Import and Export Ordinance (Amendment of Schedules 2 and 3) Notice 2003 under the Import and Export Ordinance (Cap. 60) to add Global e-Trading Services Limited to the lists of specified bodies and specified agents (copy at Annex 2); and
  - (b) the Dutiable Commodities Ordinance (Amendment of Schedules 1A and 1B) Notice 2003 under the Dutiable Commodities Ordinance (Cap. 109) to add Global e-Trading Services Limited to the lists of specified electronic service providers and specified eligible agents (copy at Annex 3).

These two Notices will take effect from 1 January 2004. They will be published in the Gazette on 17 October 2003 and tabled at the Legislative Council meeting on 22 October 2003 for the negative vetting procedures.
