

**Invitation for Proposals for the
Development of the West Kowloon Cultural District:
Extension of deadline for submission of Proposals**

We write to inform you as a holder of the above-mentioned Invitation for Proposals that, in response to views expressed by Members of the Legislative Council in a motion debate on the West Kowloon Cultural District project in the Council on 26 November 2003, the Government has decided that, pursuant to Section 2.4.9 of the Invitation For Proposals, the deadline for submission of Proposals shall be extended from 12:00 noon on Friday, 19 March 2004 to 12:00 noon on Saturday, 19 June 2004.

We decided on the extension to allow more time for the relevant sectors to provide further views on the content and possible modes of governance and operation of the arts and cultural facilities and matters to be taken into account in applying the Assessment Criteria.
