### Motion Debate on "Policy on Broadcasting"

I refer to your letter of 19 February 2004, which requested us to provide a bilingual progress report in relation to the motion carried on 18 February 2004. The motion mainly called on the Government to set up public access TV channels.

As stated by the Secretary for Commerce, Industry and Technology in his speech during the debate, the Administration will not set up public access TV channels. We maintain that there is no need for such channels in Hong Kong given that the vibrant broadcasting sector has been providing a diversity of services catering to the needs of a wide spectrum of audiences. Government and statutory organizations may flexibly partner with broadcasters to produce and broadcast programmes for specific purposes. Furthermore, new media such as the Internet are serving as effective platforms for the expression of different opinions and niche multi-media services for special interest groups.

Unlike the US, Canada and other countries where such public access channels exist, Hong Kong is geographically small and compact with a relatively homogeneous population. Under such circumstances, the communication needs of the community are adequately met by the varied services of the vibrant broadcasting sector.
