**Capital Works Reserve Fund Head 710 Computerisation
Subhead A007GX – New Administrative Computer Systems**

Introduction

This paper briefs Members on the funding requirement for 2004-05 for the implementation of computerisation projects under this Head.

Background

2. CWRP Head 710 Computerisation is the Head of Expenditure for funding administrative computer system projects. Projects which cost more than \$10 million are funded under separate subheads and are subject to the specific approval of this Council's Finance Committee.

3. Projects costing between \$150,001 and \$10 million are funded through a block allocation under Subhead A007GX which is for new administrative computer systems, and consultancies for feasibility studies and system development.

4. Projects costing not more than \$150,000 are funded from the respective Operational Expenses subheads of individual bureaux and departments, under the General Revenue Account.

Funding Requirement for 2004-05

5. Based on proposals submitted by bureaux and departments, we estimate that in 2004-05 a block allocation of \$540 million will be required to fund 286 administrative computer system projects. Of this, \$310 million is needed to fund projects initiated in 2003-04 or earlier. The balance of \$230 million is required to fund 86 new bids. A breakdown of the funding requirements is at Annex A.

6. In 2002-03 and 2003-04, the block allocation was \$690 million. The proposed allocation for 2004-05 represents a 22% reduction over the previous year's provision. Balancing the need for fiscal prudence with the need to sustain the E-government programme, and taking into account past expenditure pattern, we consider that \$540 million is appropriate for this vote.

7. The new projects to be implemented include four main programmes, namely projects related to the provision of electronic services to citizens and businesses, projects to support departmental operations, projects related to office automation and the building up of IT infrastructure in government departments, and projects to enhance IT security. Details of 20 representative projects are set out at Annex B.

8. To take full advantage of computerisation to improve operational efficiency and the quality of services delivered to the public, we have introduced in 2003-04 a requirement that all bureaux and departments must explore business process re-engineering (BPR) opportunities when implementing computerisation projects. We have conducted an initial BPR vetting on all new bids and as a result, most will be required to conduct an in-house BPR study or to incorporate this into the feasibility study or system analysis and design stages of the project.

Submission of Funding Application to the Finance Committee

9. Funding approval for all CWRF block allocations (including the Subhead A007GX block allocation) will be sought from Finance Committee, after endorsement from the Public Works Subcommittee has been received. The Financial Services and the Treasury Bureau will seek funding approval for the proposed allocations for 2004-05 in respect of all CWRF block allocation subheads, in early 2004.
