Further to our previous letter of 17 February, the supplementary information required under item (b) of your letter of 29 January is provided below.

The total number of Category A projects in the Public Works Programme to be managed by CED and TDD is expected to be around 60 in 2004-05 (excluding those which have been substantially completed) and there were about 70 such projects in 2003-04. A list of projects in 2004-05, excluding those which have been substantially completed, is at Annex. These projects will continue to be in active progress after the merging of the CED and TDD and so far there is no plan that any of these projects will be cancelled, held up or deferred. Major projects under construction include Penny's Bay Reclamation and Infrastructure for Penny's Bay Development, Development near Choi Wan Road and Jordan Valley, Container Terminal 9 Infrastructure, Construction of Road T3 and Yuen Long Bypass Floodway.

Apart from managing the above-mentioned projects under the Public Works Programme, the new CEDD will continue to play a major role in the implementation of landslip prevention measures, the enhancement of slope safety standard, the maintenance of port infrastructure and navigation channels and the management of public fills and marine fills. These ongoing projects will continue to be managed under major programme areas of the new department.
