Hong Kong Special Administrative Region (HKSAR) Identity Card Project: Progress Report

Purpose

This paper updates Members on the progress of the HKSAR Identity (ID) Card Project.

Progress of the ID Card Replacement Exercise

2. The replacement exercise has been making good progress since August 2003 and we are now in the midst of the second cycle of the exercise. The third cycle, applicable to persons born in 1952 to 1957 and cross-boundary drivers, will commence on 27 September 2004. As at mid-June 2004, the Immigration Department (ImmD) has received 1.1 million applications for ID cards under this exercise.

Revised Programme for the Replacement Exercise

- 3. The original programme of the replacement exercise (**Annex A**) comprises 28 phases in eight cycles and covers the period from August 2003 to June 2007. Taking into account the experience gained from the replacement exercise so far and the actual turnout rates, ImmD has revised the programme from the fourth cycle, i.e. Cycle D, onwards. The revised programme at **Annex B** has the following features:
 - (a) the completion date of the replacement exercise will be advanced by three months from end-June 2007 to end-March 2007;
 - (b) certain age groups are combined in order to achieve fewer cycles and phases (for example, people born in 1947 to 1949 are grouped into one phase); and

- (c) there are slight adjustments to meet the needs of specific age groups (for example, people of schooling age are arranged to apply for ID cards during the summer vacation).
- 4. The revised programme will result in savings of around \$36 million on staff costs and overheads in maintaining the nine Smart ID Card Centres.
- 5. Notwithstanding the advancement of the completion date of the replacement exercise, the standard of service to the public will not be affected. The daily quota of 6 350 for the nine Smart ID Card Centres will remain unchanged. Applicants can normally complete the application procedures within the pledged time of 60 minutes.

Publicity

6. Information on the replacement exercise will continue to be disseminated through posters, leaflets, short videos, press advertisement, Announcements of Public Interest on radio and television, the Immigration Department's telephone enquiry system and homepages. The Hong Kong Economic and Trade Offices overseas and in Guangzhou and the Beijing Office will disseminate the above information to Hong Kong residents living outside Hong Kong.

Public Feedback

- 7. Since the commencement of the exercise, we have received encouraging and favourable feedback from the public, particularly on the state-of-the-art design of the smart ID cards and the comfortable environment at the Smart ID Card Centres, etc.
- 8. Rated in terms of the project's technical proficiency, impact on the cardholders and volume of cards issued, Hong Kong smart ID card project was awarded the Card Technology Breakthrough Award in the implementation category by the Card Technology Magazine in 2004.
