**Panel on Housing
Follow-up to Meeting on 10 May 2005**

Thank you for your letter of 31 May 2005.

We have reserved seven school sites within the Development near Choi Wan Road and Jordan Valley as part of our long-term planning for school building projects. We have yet to determine the exact uses of the sites (e.g. for whole-day conversion of bi-sessional primary schools, redevelopment and reprovisioning) and the school sponsors to whom the sites will be allocated. These will be decided at a later stage taking into account, inter alia, the progress of the technical feasibility study and the latest demand for school sites serving different education objectives.

As the sites in question are still at a relatively early stage of the planning process and are yet to be allocated, they are not among the 41 allocated school projects which this bureau has reviewed recently and is re-visiting in the light of our discussion with the Panel of Education on 30 May 2005. That said, the planning parameters which we have proposed in the context of that review may have a bearing on our considerations over the uses of the seven sites.

For Members' information, the technical feasibility studies for the two primary school sites have been completed while those for the five secondary school sites are expected to commence by phases later.

二零零五年五月三十一日來函收悉。

本局已在彩雲道及佐敦谷毗鄰發展計劃的範圍內，預留七幅建校用地，作為長遠建校計劃的一部分。我們仍未確定如何使用該批建校用地(例如供作上下午班制小學轉為全日制，或學校重建及重置之用)，以及分配予哪些辦學團體。我們會在較後時間，考慮技術可行性研究的進度，以及對達致不同教育目標的建校用地的最新需求等多項因素，然後作出有關決定。

由於上述建校用地仍處於較早期的規劃階段，而且尚未分配予任何辦學團體，因此該批用地不在本局最近就 41 項已分配予辦學團體的建校項目所作檢討的範圍內。因應教育事務委員會在本年五月三十日的會議上提出的意見，本局現正覆核該 41 項建校項目。儘管如此，我們在該檢討中提出的規劃參數，有可能影響我們考慮本函件提及的七幅建校用地的用途。

請各委員備悉，該七幅用地中其中兩幅小學用地的技術可行性研究已經完成，而另外五幅中學用地的研究將會分期進行。
