Bills Committee on Securities and Futures (Amendment) Bill 2005

Meeting on Wednesday 22 March 2006

In connection with the Bills Committee's deliberation on the accountability of the proposed split model of the Securities and Futures Commission (SFC) comprising a non-executive Chairman and a Chief Executive Officer (CEO), Ms Emily Lau has referred to relevant provisions in the Urban Renewal Authority Ordinance (Cap. 563) (section 9) and the Kowloon-Canton Railway Corporation Ordinance (Cap. 372) (section 6A) and noted that there are explicit provisions requiring the non-executive Chairman and the executive directors/CEO of these bodies to attend meetings of committees and subcommittees of the Legislative Council. To enhance accountability, Ms LAU suggests that consideration should be given to including a similar provision in the current Bill so as to make the Chairman and CEO of SFC more accountable to the legislature.

2. Hon SIN Chung-kai, Chairman of the Bills Committee, has instructed that Ms LAU's concern should be referred to the Administration for consideration and response. The Administration has been requested to provide its response at the Bills Committee meeting to be held on 22 March 2006. Extracts of the relevant sections of the aforesaid Ordinances are now attached for members' information.
