Issues which required follow-up actions/consideration by the Administration

Administration's response to issues raised by members at the meeting on 14 June 2005 (CB(1)1907/04-05(01))

3. On the proposed Personalized Vehicle Registration Marks (PVRM) combinations, the Administration considered that allowing 8 characters without

grouping restrictions for PVRMs would give vehicle owners more room for creativity and more choices. The PVRMs Scheme would not give rise to concerns about law enforcement. Nevertheless, the Administration undertook to review this arrangement one year after the implementation of the PVRMs Scheme.

- 4. On law enforcement, the Hong Kong Police Force (the Police) considered that the present training provided to frontline police officers before they were posted to the Traffic Formations would be adequate to enable them to carry out enforcement duties even if the proposed PVRMs Scheme was implemented. Nevertheless, the Police would consider stepping up the relevant training for frontline police officers if such an operational need arose from the implementation of the proposed Scheme. The Police further advised that implications on enforcement of the proposed requirement that not more than four identical letters or numerals should be placed side by side in a PVRM would also be examined in the light of operational experience of the proposed Scheme.
- 5. <u>The Chairman</u> advised that individual members or the Bills Committee holding views different from those of the Administration on the PVRM combinations and/or other aspects of the Bill might, in due course, consider moving Committee Stage amendments to the Bill.

Clause-by-clause examination

Clause 10 – Regulation 12K

- 6. <u>Some members</u> suggested reserving PVRMs which were the same as certain company names such as HSBC, IBM etc for allocation to the companies concerned with a view to increasing the attractiveness of the PVRMs Scheme and generating more auction proceeds channeled to poverty-alleviation initiatives. <u>The Administration</u> considered that it was not practicable because it would not be equitable to deny individuals who might be interested in applying for these PVRMs, such as when their surnames were the same as company names like SWIRE or WILSON.
- 7. <u>The Chairman</u> suggested that the Administration might consider expanding the scope of PVRMs specified in Schedule 5A of the Road Traffic (Registration and Licensing of Vehicles) Regulations to include PVRMs of three or four identical letters for allocation upon sale by auction in the Commissioner for Transport's discretion. <u>The Administration</u> noted the Chairman's suggestion for consideration.

Clause 10 – Regulation 12L

8. <u>Mr Albert CHENG</u> and <u>the Chairman</u> enquired about the arrangements for re-assigning a cancelled or recalled PVRM when the grounds leading to such cancellation or recall no longer existed. <u>The Administration</u> undertook to revert to the Bills Committee on the arrangements.

Clause 10 – Regulation 12M

9. Regarding regulation 12M(1)(a), Mr SIN Chung-kai did not consider it necessary to require the PVRM holder to keep a certificate of allocation for a PVRM and to return the certificate to the Commissioner for Transport in case of recall/cancellation of the PVRM. The Administration agreed to consider whether the requirement could be simplified, such as by incorporating the information contained in the certificate of allocation in the existing vehicle registration document.

Further meetings of the Bill Committee

10. Ms Miriam LAU relayed Mrs Selina CHOW's suggestion that the Bills Committee should invite deputations to give views on the PVRM Scheme proposed under the Bill. In this connection, the Chairman said that Mrs CHOW should be advised that the Bills Committee had invited submissions previously and met with deputations on 14 June 2005. However, Mrs CHOW was welcome to notify the Secretariat if there were organizations/individuals which would like to submit views to or meet with the Bills Committee.
