I. Meeting with the Administration

(LC Paper Nos. CB(2)434/04-05(01), CB(2)475/04-05(01), CB(2)580/04-05(01) to (03), CB(2)630/04-05(01) to (02), CB(2)673/04-05(01), IN18/04-05 and IN19/04-05)

The Bills Committee deliberated (Index of proceedings at Annex).

2. The Administration was requested to respond in writing to the following suggestions made by members at the meeting -

(a) to henceforth collect statistics on the number of people who suffered ill health as a result of consuming health food products making claims relating to the regulation of immune system and the promotion of detoxification and slimming/fat reduction and delaying proper treatment; and

(b) to separate the regulation of health claims of health food products from the regulation of health claims made by registered medicines, having regard to the fact that the latter's safety, quality and efficacy had to be vetted and approved by the relevant authorities before they could be sold in Hong Kong.

3. At the request of the Bills Committee, <u>the Administration</u> undertook to provide a breakdown of the types of complaints relating to health food lodged with the Consumer Council from 2001 to 2004.

- 4. <u>The Administration</u> agreed to consider -
 - (a) recasting the allowable claims in the Bill along the lines which would allow manufacturers of the registered pharmaceutical products, registered proprietary Chinese medicine to advertise the health claims of their products more explicitly but with the proviso that the products concerned might not be beneficial to every consumer; and
 - (b) making clear the meaning of "health food" or "customarily consumed food" in the Bill.

<u>Members</u> requested that any revised allowable claims and the new definition of "orally consumed food" be provided to the Bills Committee for consideration.

5. The Research and Library Services Division of the Legislative Council Secretariat was requested to conduct research on the following areas -

- (a) regulation of claims of health food relating to the regulation of immune system and the promotion of detoxification and slimming/fat reduction in the United States, United Kingdom, European Union, the Mainland and Taiwan; and
- (b) regulation of health claims of health food and registered medicines in overseas jurisdictions.

II. Dates of next meetings

- 6. <u>Members</u> agreed to hold the next two meetings on the following dates -
 - (a) 17 February 2005 at 4:30 pm; and
 - (b) 24 February 2005 at 4:30 pm.

7. <u>Members</u> further agreed to invite representatives from the media, advertising firms, patients' groups and the Consumer Council to give views on the publication and regulation of health claims at the next meeting on 17 February 2005.
