#### I. Meeting with the Administration

(LC Paper Nos. CB(2)1602/04-05(01) to (04), CB(2)1069/04-05(01), CB(2)1209/04-05(01), CB(2)1395/04-05(01) and IN27/04-05 to IN29/04-05)

The Bills Committee deliberated (Index of proceedings at Annex).

- 2. <u>The Administration</u> undertook to provide the proposed Committee Stage amendments to the Undesirable Medical Advertisements (Amendment) (No.2) Bill 2004 (the Bill) on the following in the first week of June 2005 -
  - (a) allowable claims in respect of items 4, 5 and 6 in the proposed Schedule 4;
  - (b) definition of "orally consumed product"; and
  - (c) exemption power of the Director of Health (D of Health) under new section 3B.
- 3. During the discussion of the allowable claims, <u>Deputy Secretary for Health</u>, <u>Welfare and Food</u> (DSHWF) remarked that the Secretary for Health Welfare and Food (SHWF) would reaffirm in his speech to be given at the resumption of Second Reading debate on the Bill that there was nothing in the Undesirable Medical Advertisements Ordinance (UMAO) that prohibited the industry in stating in the advertisement the registration status of a specific drug.

- 4. In response to Dr KWOK Ka-ki, <u>DSHWF</u> said that improvements had been made to the warning letters. A guideline setting out the criteria of the Department of Health would look at when screening problematic advertisements was already underway.
- 5. <u>Dr KWOK Ka-ki</u> requested SHWF to give an undertaking, in the same speech referred to in paragraph 3 above, to review the inclusion of the regulation of body immune system, the promotion of detoxification and the promotion of slimming/fat reduction in the Bill and to give an indication of the timing of the review.
- 6. <u>The Chairman</u> also requested SHWF to respond to the request made by the 《不良醫藥廣告條例》業界關注聯盟 (Annex B to LC Paper No. CB(2)1602/04-05(03)) in the same speech referred to earlier with regard to revamping the UMAO to make it better meet the present day circumstances.
