I. Meeting with the Administration

(LC Paper No. CB(2)1857/04-05(01) – Draft Committee Stage amendments (CSAs) to the Bill provided by the Administration)

<u>The Bills Committee</u> considered the draft CSAs to be moved by the Administration in conjunction with the marked-up copy of the CSAs (English version) prepared by the Legal Services Division which had been tabled at the meeting.

2. <u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

Proposed CSAs to introduce savings provisions in clause 15 of the Bill in relation to transfer of power to make rules from the Chief Justice (CJ) to the Chief Judge of the High Court (CJHC) under various Ordinances

3. <u>The Chairman and Ms Audrey EU</u> enquired about the reasons for introducing the savings provisions, which specified that any rules made, or any directions issued or given, under the relevant Ordinances by CJ which were in force immediately before

the commencement of clause 15, when enacted, should continue in force as if the rules were made, or the directions were issued or given, under those Ordinances by CJHC. The Administration replied that the proposed savings provisions would ensure the continuity of the existing rules and directions made by CJ, and enable CJHC to amend them after the transfer of power from CJ.

4. <u>The Chairman</u> considered that the existing provisions in section 28 of the Interpretation and General Clauses Ordinance (Cap. 1) on transfer of power to make subsidiary legislation were sufficient to deal with the issue in question. She requested the Administration to provide a written response to substantiate the grounds for introducing the amendments.

- 5. <u>The Bills Committee</u> completed the scrutiny of the CSAs and agreed to the proposed amendments.
- 6. <u>The Chairman</u> asked the Legal Adviser to the Bills Committee to study the Chinese version of the CSAs and advise whether they were in order after the meeting.

(*Post-meeting note*: The Legal Adviser had advised that the Chinese version of the CSAs were in order. Marked-up copies of the CSAs in both Chinese and English versions were issued to the Bills Committee on 14 June 2005 vide LC Paper No. CB(2)1921/04-05(02))
