Action

I. Meeting with deputations and the Administration

Staff-to-children ratio

- 3. <u>Members</u> noted that deputations in general supported enactment of the Bill, but deputations from the aided child care service sector considered that the proposal to align the staff-to-children ratio of existing day nurseries (DNs) and kindergartens (KGs) to 1:15 upon harmonisation would have adverse effects on the operation of existing DNs which were now subject to a staff-to-children ratio of 1:14. Deputations from the KG sector, however, pointed out that KGs had already taken a great step to improve the staff-to-children ratio from 1:30 to 1:15 over the past few years. <u>Members</u> in general considered that harmonisation of pre-primary services should aim at improving quality of services in KGs/child care centres (CCCs). They shared the concerns of deputations from the aided child care service sector and suggested that the Administration should consider adopting a staff-to-children ratio of 1:14 for both KGs and CCCs for children of two or more years of age upon harmonisation.
- 4. The Administration explained that the Child Care Services Ordinance and the Education Ordinance had different requirements on staff-to-children ratio. The improved ratio of 1:15 for KGs was implemented in the 2003-04 school year by administrative measures. Given that the number of children attending KGs was far greater than those in DNs, the Administration proposed adopting the ratio of 1:15 for all children aged two to six as the minimum standard. The ratio was only a minimum standard and operators were free to adopt a more generous ratio. In view of members' concern and suggestion, the Administration undertook to explore the

feasibility of improving the staff-to-children ratio from 1:15 to 1:14 for both CCCs for children of two or more years of age and KGs upon harmonisation.

Operation of kitchen

5. <u>Members</u> noted the concerns of deputations from the child care service sector and the KG sector regarding the existing requirement for DNs offering full-day programme to operate a kitchen to provide meals for their children. While the child care service sector in general considered the provision of kitchen in CCCs or KG-cum-CCCs upon harmonisation essential for provision of nutritious meals for children, a deputation from the KG sector had pointed out that many existing KGs were not having kitchens in conformity with the required standards. Some members had expressed support for the retention of the existing requirement for CCCs operating on a full day basis to have a kitchen upon harmonisation.

Follow-up action to be undertaken

- 6. The Administration was requested to
 - (a) explain the financial implications of improving the staff-to-children ratio from 1:15 to 1:14 on the provision of subvention to and the operation of CCCs upon harmonisation;
 - (b) provide a breakdown of the different levels of financial assistance provided under the existing Child Care Centre Fee Assistance Scheme and the enhanced Kindergarten Fee Remission Scheme for families with different levels of income; and
 - (c) elaborate on the effects of the requirement of operating a standard kitchen to provide meals for children on existing KGs upon harmonisation.
