I. Meeting with the Administration

The Bills Committee discussed items A to R in the Administration's paper entitled "Consolidated Response - The Administration's response to Members' suggestions/views" [LC Paper No. CB(2)2368/05-06(01)] (index of proceedings attached at **Annex**).

Appointment of proxy

2. Members ro

- 2. <u>Members</u> remained of the view that an owners' corporation should be required to keep proxy instruments for a certain period of time, say one month, after the holding of the owners' meeting. <u>The Administration</u> was requested to reconsider.
- 3. <u>The Chairman</u> expressed concern that there would be a direct conflict of interest in case of tie vote if the chairman of a management committee (MC) was given the final power to determine the validity of proxy instruments. He suggested that the Administration in the future should devise necessary solution to avoid possible conflict of interest.
- 4. <u>Mr LI Kwok-ying</u> expressed the view that owners should be given the option to indicate the date and time of signing in the proxy instruments and if there were two or more proxy instruments from the same owner, the proxy instrument with indication of the latest date and time of signing should be accepted as the proxy last appointed and there was no need to seek clarification from the owner concerned. <u>The Chairman</u> and <u>Mr Alan LEONG</u> did not agree with Mr LI's view.

Communications among owners

5. On the Administration's proposal of including a new paragraph under Schedule 7 to require a building manager to consult the owners' committee, and if there was a corporation, the general meeting of owners, and adopt their decision on the channels of communication among owners on any business relating to the management of the building, the Chairman expressed concern that communications among owners on matters relating to building management could still be banned by a majority decision.

<u>Inspection of documents</u>

6. <u>The Chairman</u> was strongly of the view that owners should be allowed under the Building Management Ordinance (BMO) to inspect all bills, invoices, vouchers, receipts and other documents kept by an MC as required by paragraph 1 in the Sixth Schedule to BMO. He considered that owners should at least be given the right to apply for a court order to do so. <u>The Chairman</u> indicated that he might consider moving Committee Stage amendments in this regard. He requested the Administration to reconsider his view.
