# I. Meeting with the Administration

[LC Paper Nos. CB(3)477/04-05, CB(2)3140/05-06(01) and (02)]

#### Clause-by-clause examination of the Bill

The Bills Committee completed examination of clause 4 of the Bill (Appointment of management committee (MC)) and the relevant Committee Stage amendments (CSAs) to be proposed by the Administration. (Index of proceedings attached in **Annex**).

Proposed new section 3(10)(a)(i)

2. The Chairman requested the Administration to consider making reference to the Wills Ordinance (Cap. 30) and introducing into the Building Management Ordinance (BMO) the concept that signing by another person, in the presence of an owner, would also be deemed as a valid signature of that owner, in order to cater for the needs of owners who were physically incapable of signing. Ms Miriam LAU, however, expressed worry that the validity of such a signature might be subject to disputes. She pointed out that the Wills Ordinance required that the signature had to be made or acknowledged by the testator in the presence of two or more witnesses present at the same time when the signing took place. Ms LAU requested the Administration to confirm whether the making of a thumbprint or a cross would be accepted as "signing" in this context.

Proposed new section 3(10)(a)(ii)

3. <u>The Administration</u> was requested to explain what would constitute a valid authorization by a body corporate, e.g. whether proof of authorization would require a letter issued by or relevant minutes of meeting of the body corporate.

- 4. <u>The Administration</u> was also requested to review the drafting of the expression "be sealed or stamped with the seal or stamp...", having regard to the following members' suggestions and views -
  - (a) the expression could be revised as "be sealed with a seal or be stamped with a stamp";
  - (b) the word "chop" could be used instead of "stamp"; and
  - (c) a generic English term could be used instead of the phrase "sealed or stamped".

Proposed new section 3(10)(b) to (e)

5. On proposed new section 3(10)(e)(i) and (iii), the Administration was requested to consider whether reference to "flat" in the former provision and other relevant provisions covered the meaning of houses within a house development and, if so, whether reference to "address" in the latter should be substituted with reference to "flat" or any other better term.

- 6. On the determination of the validity of proxy instruments, the Administration was requested to -
  - (a) explain what the convenor would need to do in order to discharge this statutory duty; and
  - (b) consider the suggestion of Ms Audrey EU and Mr Albert HO that the convenor should be given statutory protection under the proposed new section 29A in the course of performing his duty under the proposed new section 3(10)(e)(ii).
- 7. Mr Albert HO also suggested that, if the convenor had adopted the advice of the Liaison Officer in determining the validity of proxy instrument, it could be used as an immunity against any claim for his personal liability in the course of exercising such statutory power. The Administration responded that representatives of the Home Affairs Department attending meetings of owners did not play the role of providing legal advice on procedures under BMO.

Suggestion of putting in place a central mechanism for convening a meeting of owners to appoint an MC

8. <u>Ms Emily LAU</u> pointed out that many owners remained concerned that, notwithstanding better protection afforded to them by the proposed amendments to existing provisions, there might still be problems, e.g. collusion between the building manager and the convenor or existing MC perverting the appointment process. These owners preferred to a central mechanism to be put in place by the Administration for conducting the appointment of MC, including verification of proxy instruments. She added that it would be acceptable to owners even though the service would be provided on a fee-charging basis under the proposed mechanism. <u>Ms Audrey EU</u> also considered that such mechanism should be put in place to provide, at least, the service of convening a meeting of owners for the appointment of an MC. <u>Mr Albert HO</u>, however, expressed reservation about the suggestion.

9. The Chairman requested the Administration to consider members' views and revert to the Bills Committee later. He said that the Bills Committee could discuss issues relating to the implementation of new provisions, e.g. strengthening of publicity and relevant guidelines on new statutory requirements to be introduced under BMO at future meetings. The Bills Committee could also consider referring relevant issues to the Panel on Home Affairs for follow-up discussion.

#### Administration's responses to members' concerns
