I. Clause-by-clause examination of the Bill

(The Bill, marked-up copy of the Bill and LC Paper No. CB(2)901/05-06(03))

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

- 2. The Administration was requested to provide a written response to the following suggestions made by members at the meeting -
 - (a) to delete "被人" from paragraph (a) of the Chinese version of the definition of "workplace" in clause 4(h), so as to be consistent with the English version of that clause;
 - (b) to make clear whether the proposed smoking ban would include serviced apartments, regardless of whether these apartments were located inside a residential or commercial building;

- (c) to make clear whether premises provided by employers for their employees as sleeping accommodation in new section 3(5)(b) would cover those located at the back or in the attic of the workplace and those covered in the lease of the workplace but were located away from the workplace, having regard to the definition of "workplace" in clause 4(h) which meant areas "including any part of the place that is set aside for use by those persons during any interval for taking a meal or rest";
- (d) to consider imposing a smoking ban on the outdoor areas of all public markets and all specified educational establishment and post-secondary schools;
- (e) to consider specifying in the definition of "public market" in clause 4(h) that it covered all markets, irrespective of their operators/managers;
- (f) to ascertain whether premises used for habitation, but sometimes used for commercial activities involving non-inhabitants of that premises, such as running a private kitchen, also fell under the definition of "domestic premises" in clause 4(h);
- (g) to consider amending the definition of "domestic premises" in clause 4(h) along the lines that domestic premises meant any premises used for habitation; and
- (h) to clarify with the Transport Department whether taxi not on hire would not be considered a public transport carrier, and hence taxi drivers would not be in breach of the smoking ban under the Smoking (Public Health) Ordinance (Cap. 371) if they smoked or carried a lighted tobacco product when they were not carrying passengers in their taxis.
- 3. <u>The Administration</u> advised members that it intended to examine how smoking ban should be imposed on private transport carrier, such as private car, hired car and school bus, at an appropriate time after the enactment of the Bill.
- 4. <u>The Administration</u> undertook to provide a sample of a certificate of registration of a child care centre, which contained details of the premises where the centre might be operated, among others, after the meeting.
