#### I. Meeting with the Administration

(LC Paper Nos. CB(2)2054/05-06(01) and CB(2)2055/05-06(01) to (03))

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Administration was requested to provide a response in writing to the following suggestions raised by members at the meeting -
  - (a) managers of statutory no smoking areas should still be required under the law to put up "no smoking" signs in designated no smoking areas, so that people entering these areas were well aware that they could not smoke while they were therein;
  - (b) apart from the "specified educational establishment", the employees' accommodation situated within the premises of all other educational institutions listed under Schedule 2 to the Bill should also be exempted

from the smoking ban if such accommodation was not communal and had independent ventilation;

- (c) information on other local legislation which contained a provision requiring any person to give his name and address and to produce proof of identity if the inspector reasonably suspected that the person was able to provide evidence of the commission of a relevant offence, as stipulated under the proposed new section 15G(1)(d); and
- (d) the English font size of the health warning on the price board of tobacco products should be made bigger to commensurate with the Chinese font size of the health warning on the same.

#### 3. <u>The Administration</u> agreed to -

- (a) ascertain whether there was any need to include massage establishments in the list of premises to be exempted from the smoking ban until 1 July 2009; and
- (b) brief the Panel on Health Services in due course on the Tobacco Control Office guidelines on handling people smoking or holding a lighted tobacco product in a no smoking area.

#### II. Date of next meeting

- 4. <u>Members</u> noted that the next meeting would be held on 23 May 2006 from 8:30 am to 12:30 pm to listen to the views of deputations on the Committee Stage amendments proposed by the Administration and individual members.
