I. Discussion of report entitled "Smoking Costs Hong Kong Over \$5 billion every year: First Report of a Comprehensive Assessment in Asia" completed in February 2005 by the Faculty of Medicine of the University of Hong Kong

(LC Paper No. CB(2)2097/04-05(01))

<u>The Bills Committee</u> deliberated (Index of proceedings at **Annex**).

2. At the invitation of the Chairman, <u>Dr Sarah McGhee of the University of Hong Kong</u> briefed members on the salient points of the above report through the aid of powerpoint.

II. Meeting with the Administration

(LC Paper Nos. CB(2)2097/04-05(02) to (05), CB(2)2147/04-05(01), CB(2)2152/04-05(01) to (03) and CB(2)2164/04-05(01) to (03))

- 3. At the request of the Bills Committee, the Administration undertook to provide a response in writing to the following requests raised by members -
 - (a) check with the Police on the number of incidents which Police assistance was sought for dealing with persons who refused to abide by the statutory smoking ban in certain indoor public places, such as shopping malls, supermarkets, banks and departments, and in the smokefree seating areas of restaurants providing indoor seating accommodation for more than 200 persons, which came into operation in July 1999; and
 - (b) consider how best to enforce the provision under the Smoking (Public Health) Ordinance (the Ordinance) which allowed managers and authorised persons of designated no smoking areas and public transport carriers to resort to use force against persons who refused to abide by the statutory no smoking requirement; alternatively, to consider drawing up a set of guidelines on the use of such force, and consider whether such guidelines should be discussed by the Labour Advisory Board.
- 4. The Administration was also requested to provide a response in writing to the

following information requested by members -

- (a) number of incidents whereby aircraft crew were required to resort to use force against passengers who refused to abide by the statutory no smoking ban inside the aircraft since such a ban had come into operation some 10 years ago;
- (b) number of prosecutions and convictions pursuant to section 3(2) of the Ordinance from July 1999 up to 2001;
- (c) venues where the prosecutions and convictions pursuant to section 3(2) of the Ordinance from July 1999 to 2004 had occurred;
- (d) reason(s) why some prosecutions referred to in paragraph 4(c) above had ended in no conviction; and
- (e) number of prosecutions referred to in paragraph 4(c) above whereby employees had appeared as witnesses; among these witnesses, how many of them had met with threat and/or assault from the persons being prosecuted.
