I. Meeting with Japan Tobacco Inc.

(LC Paper No. CB(2)407/05-06(01))

The Bills Committee deliberated (index of proceedings attached at Annex).

- 2. The Administration was requested to provide legal opinion on a ruling made by the Illinois Supreme Court on 15 December 2005, which reversed the trial court's judgement that Philip Morris USA had defrauded "Lights" smokers by suggesting to them "Marlboro Lights" and "Cambridge Lights" were actually less hazardous than their full-flavour brands. The Court concluded that the company was specifically authorised to use descriptors such as "light" and "low tar" by the Federal Trade Commission, and therefore the company is exempt from civil liability under section 10b(1) of the Illinois Consumer Fraud Act for the use of those terms. For the same reason, the Court concluded that the company is exempt from civil liability under the Illinois Deceptive Practices Act.
- 3. Barker and McKenize was requested to provide the respective legal opinions provided by Mr Michael Thomas, QC and Mr Benjamin YU, SC on the Basic Law and the Bill of Rights implications of clause 11 of the Bill, which sought to prohibit the appearance of the words "light", "lights", "mild", "low tar" or other words that might have similar misleading effects on any package of tobacco products.
