- 2. The Bills Committee deliberated (index of proceedings attached at **Annex**).
- 3. <u>Members</u> noted the position of the Administration that in addition to the cost of recovery of the disposal of the imported waste, an application fee would be charged. Other than that, it was not necessary to increase the charge payable by an applicant for the disposal of imported non-hazardous waste at local landfills under proposed section 20DA(6)(a).

Adm 4. The Administration was requested to –

- (a) provide a written response to the submission of Greenpeace within this week and copied it to Greenpeace for comments;
- (b) review whether "業務" or "執業" should be adopted as the Chinese version of the word "practices" in clause 2(g) and Group 3 of Schedule 8;
- (c) consider the need to stipulate in the Bill the mechanism for announcing wastes which would be classified as "other wastes" under Group 6 of Schedule 8, as any person who failed to comply with the regulatory control framework in the Bill could commit an offence; and
- (d) advise whether the definition of "Dressings" in Group 5 clinical waste in Schedule 8 was the same as or comparable to the one adopted by the Hospital Authority and the Hong Kong Medical Association.
- 5. <u>The Administration</u> undertook to propose Committee Stage amendments (CSAs) to the following clauses
 - (a) clause 18 to amend the Chinese version of proposed section 23D(e) for better linguistic flow;

- (b) clause 21 to amend proposed section 33(1A)(a)(ix) to authorize healthcare professionals who transported clinical waste received at their clinics (as collection points) to a reception point;
- (c) Schedule 8 to add an exception to Group 3 clinical waste to the effect that extracted teeth would not be classified as clinical waste;
- (d) Schedule 8 to replace "veterinary sources" in Group 3 clinical waste with "veterinary practices";
- (e) Schedule 8 to include a new pathogen in Group 4; and
- (f) Schedule 9 to specify that member countries of the Organization for Economic Co-operation and Development and European Union would be included in the Schedule.
- 6. <u>The Bills Committee</u> completed clause by clause examination of the Bill in both English and Chinese versions, except clauses 23 and 24 which would be scrutinized together with the Administration's response to the submission of Greenpeace at the next meeting. <u>Members</u> also agreed that Schedule 9 would be revisited when the CSA was available.
