- (d) provide information on the mechanism for handling complaints against the signatory states to the Basel Convention for non-compliance with the Convention, and whether complaints had been lodged against Hong Kong;
- (e) provide information on Environmental Protection Department's involvement in the Cluster on Transfrontier Shipments of Waste of the IMPEL Network on the enforcement measures taken by Hong Kong to stop illegal waste shipments; and

		Administration responded with the following points –	
		(a) the list of hazardous waste in the Seventh Schedule to WDO enacted in 1994/95 was modeled along the Organisation for Economic Co-operation and Development (OECD) lists. The list in Annex VIII, on the other hand, was included in the Basel Convention in 1998;	
		(b) certain types of waste listed in Annex VIII made reference to hazardous properties in Annex III, which were not fully documented and the tests did not exist to define quantitatively the hazards. It was premature for WDO to adopt the list in Annex III & VIII to the Basel Convention;	
		(c) it was not uncommon for individual signatory states to the Basel Convention to modify the definitions and lists of wastes to suit their needs;	
		(d) member states of European Union (EU) used both the OECD lists (within EU) and lists in the Basel Convention (outside EU);	
		(e) amendments had been proposed to the Seventh Schedule to WDO to ensure that the hazardous waste listed in Annex VIII to the Basel Convention were sufficiently covered, e.g. AD220, a

		catch-all description, was included in the Schedule;	
		(f) "waste" was defined in the Basel Convention as substances which were "disposed of", while WDO defined it as substances which were "abandoned". The current definition of waste in WDO had proven to be successful in curbing transboundary movement of hazardous waste as evident from recent successful prosecution cases;	
		(g) practical difficulties in enforcing the definitions and lists of wastes in the Basel Convention as it would create confusion to the trade;	
		(h) revamp of WDO for the purpose of adopting the definitions and lists of wastes in the Basel Convention was a big operation and posed great risks. It involved not only technical amendments to WDO but also a new round of consultation with the trade, and an assessment on the enforceability of the new controlled measures, given that the existing system had been used for over 10 years; and	
		(i) it was not practical to follow the list of controlled wastes and import prohibitions adopted by the Mainland, as Hong Kong was a free port and also supported the spirit of the Basel Convention in respect of encouraging recycling of waste
