Bills Committee on Waste Disposal (Amendment) Bill 2005 Meeting on 26 July 2005

Thank you for inviting us to the captioned meeting.

We shall not attend the meeting. Our views, which have already been passed to the Environmental Protection Department, are reproduced below for your information.

"We met on 12 May 2005 and understood that the Clinical Waste Disposal Bill had been gazetted and the legislation process would proceed soon. We were assured that the drafted bill was basically identical to what we had agreed previously. We reiterated our position as follows:

- As a responsible profession, we basically support the idea of legislation but we would like the Administration to clarify that the necessity for legislation was not because of any incidence of health hazard caused by the small clinical waste producers.
- 2. We were told that there were more than 10 clinical waste collectors in the market. As there was not any monopoly it was expected that the collecting fee would not increase after legislation.
- 3. The clinical waste is now disposed of at landfills and the cost is about \$3/kg. Government plans to provide a long-term disposal facility for clinical waste and is in the process of reviewing different available technologies.
