I. Election of Chairman

II. Meeting with the Administration

- 3. The Bills Committee requested the Administration
 - (a) to consider providing in the Bill that a second opinion should be given by a registered Chinese medicine practitioner (CMP) if the first opinion was given by a registered CMP, and a medical practitioner (MP) if the first opinion was given by a MP;
 - (b) to provide information on overseas experience in the recognition of medical treatment, examination and certification given by a registered CMP, together with the relevant overseas legislation;
 - (c) to explain the differences between the functions of a registered CMP and a MP after the Bill was passed;
 - (d) to provide the guidelines issued by the Chinese Medicine Practitioners

Board on sick leave duration;

- (e) to provide information regarding the competency of registered CMPs in performing the tasks proposed in the Bill;
- (f) to provide information on the percentages of cases where there was objection to the assessment made by an Employees' Compensation Assessment Board on the employee's permanent loss of earning capacity;
- (g) to explain the training and experience required of a registered CMP for appointment to an Employees' Compensation (Ordinary Assessment) Board;
- (h) to advise on the training and continued education provided to MPs and registered CMPs to facilitate their assessment of permanent loss of earning capacity; and
- (i) to advise on the adequacy of manpower in the Labour Department for the provision of occupational health services.
