I. Meeting with the Administration

- 2. The Bills Committee requested the Administration -
 - (a) to consider deleting the reference to "law", "commerce" and "finance" in new clause 10(3)(a)(ii) of the Bill;
 - (b) to consider deleting the reference to "commerce" and "finance" in the proposed section 17B(3)(b) of the Hong Kong Council for Accreditation of Academic and Vocational Qualifications Ordinance;
 - (c) to consider adding in clause 35 a provision similar to new clause 12A(4) of the Bill; and
 - (d) to consider adding an express provision in the Bill to the effect that rules made under new clause 10(7) of the Bill were subsidiary legislation subject to scrutiny by the Legislative Council.

3. The Administration agreed to consider the suggestion of setting out the time-frame for dealing with appeals in the rule to be made under new clause 10(7) of the Bill.
