 - (a) to consider revising the proposed Committee Stage amendments to clause 13(4)(a)(iii) of the Bill, making reference to the wording of section 43 of the Sex Discrimination Ordinance (Cap. 480);
 - (b) to reconsider the need for the items required in clause 13(1)(a) of the Bill;
 - (c) to consider improving the drafting of the proposed Part 3, clause 11, clause 12B(4) and clause 13(4) of the Bill, having regard to the views expressed by Ms Margaret NG; and

- (d) to provide information on the manpower resources required for Industry Training Advisory Committees to draw up specification of competency standards.
- 3. The Administration undertook to state in the speech to be delivered by the Secretary for Education and Manpower during the resumption of Second Reading debate on the Bill that the Administration would report to the Panel on Manpower the progress of establishment of the Qualifications Framework in individual industries at half-yearly intervals and the results of the review of the pilot scheme on recognition of prior learning.
