- (f) to consider providing in clause 4(4)(a) that the fees should be subject to the prior approval of the Secretary for Education and Manpower.
- 3. The Administration advised that it would -
 - (a) provide the draft Committee Stage amendments (CSAs) on the powers of the Appeal Board; and
 - (b) move a CSA to delete the definition of "business" in clause 2.
