 - (d) to consider revising the drafting of clause 13(1) and 13(2) in relation to the Chinese counterpart of "unless"; and
 - (e) to consider amending clause 13(4)(a)(iii), having regard to some members' view that the clause might be too stringent to people engaged in publishing and advertising.

3. The Administration advised that it would move Committee Stage amendments to amend clause 7(4) and clause 8(3) along the lines of its proposed Committee Stage amendment to clause 3(1).
