Establishment Sub-committee Meeting on 9 June 2005

At the meeting of the Establishment Sub-committee held on 9 June 2005, Members asked the Administration to provide supplementary information on training provided to staff of the Television and Entertainment Licensing Authority (TELA) to develop and acquire new skills and knowledge to cope with challenges brought by rapid development in the broadcasting sector. The requested information provided by TELA is appended in the ensuing paragraphs.

Since the enactment of the Broadcasting Ordinance (Cap. 562) in 2000, TELA has provided a number of training programmes to its staff to enhance their capability to take up new responsibilities such as handling of competition complaints and adjust to new requirements such as renewal of licences under a technology-neutral framework. A list of the training courses provided to TELA staff since July 2000 to enhance their skills and knowledge is at **Annex**. Apart from formal training courses and

conferences, two of TELA's staff were seconded to the Commerce, Industry and Technology Bureau for exposure to policy formulation.

TELA will continue to arrange its staff to attend regulatory conferences, seminars and training courses on broadcasting issues. TELA has also approached the regulatory authorities in the UK and Australia, which have merged their broadcasting and telecommunication regulators into a unified body, to set up an attachment programme for its staff so as to provide them with more exposure to the unified regulatory set-up and the process in formulating regulatory responses to technological convergence. Furthermore, the external expert to be recruited to fill the post of Assistant Commissioner (Broadcasting) will be able to transfer his/her knowledge and experience on international regulatory practices to TELA staff.
