# Forecast of submissions for the 2004-05 Legislative Council session

This note gives an overview of potential capital works items to be submitted to the Public Works Subcommittee for consideration for the 2004-05 Legislative Council session.

- 2. The pool of items that may be ready for submission to the Public Works Subcommittee before the 2005 summer recess totals 76 as listed in Enclosure 1, including four already considered by the Subcommittee on 27 October 2004. To enable Members to have a better understanding of the items, we have provided supplementary information on each item at Enclosure 2 following the same order presented in Enclosure 1.
- 3. The Administration will try to adhere to the targets as much as possible. However, programme changes arising during the design, gazettal, and consultation stages, etc. are expected. We will account for deviations from the current forecast in a year-end report for Members' reference.

**Project Code and Title:** 3074TI – Transport link in Tsim Sha Tsui East

#### **Project Description:**

The proposed project is for the construction of a new transport link in Tsim Sha Tsui East. The latest proposed scope of the project comprises a public transport interchange (PTI) with a podium garden on top and supporting facility including toilets; and two footbridges across Salisbury Road and Chatham Road South linking the PTI with the Tsim Sha Tsui Promenade and the KCRC Station at the Middle Road Children's Playground. The project is tentatively scheduled to commence in 2005 - Q1 for completion in 2006 - Q3.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): \$200 million - \$500 million

**Previous or planned panel consultation:** We consulted the Legislative Council Panel on Economic Services on the proposed project on 24 May 2004 and plan to consult the joint Panels on Economic Services and Transport again in end 2004.

**Project Code and Title:** 4109CD – Drainage improvement in Sha Tin and Tai Po

**Policy Bureau and Branch:** Environment, Transport and Works Bureau (Works Branch)

Works Department: Drainage Services Department

# **Project Description:**

The part proposed for upgrading to Category A is for the construction of urban drainage improvement works in Sha Tin. The latest proposed scope of the part-upgrading comprises construction of about 2.5 kilometres of drains. The construction is tentatively scheduled to commence in 2005 - Q1 for completion in 2007 - Q4.

We have previously sought funding from the Finance Committee on 22 June 2001 for the detailed design, impact assessments and investigation works of the project.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Below \$200 million

**Previous or planned panel consultation:** We consulted the Legislative Council Panel on Planning, Lands and Works on 23 April 2001 on the proposal to part-upgrade 4109CD as 4115CD for employing consultants for detailed design, impact assessment and investigation works.

We plan to issue an information paper to the Legislative Council Panel on Planning, Lands and Works on the proposed works for Sha Tin in December 2004 prior to PWSC submission.

**Project Code and Title:** 4211DS – Outlying Islands sewerage, stage 1 phase 2 – Peng Chau sewage treatment works upgrade

**Policy Bureau and Branch:** Environment, Transport and Works Bureau (Environment Branch)

Works Department: Drainage Services Department

#### **Project Description:**

The proposed project is for the expansion of the treatment capacity of the existing Peng Chau sewage treatment works to meet the anticipated population growth up to 2016. The latest proposed scope of the project comprises re-construction of the Peng Chau sewage treatment works, laying of about 350m of twin inlet pumping mains and provision of submarine outfalls. The construction is tentatively scheduled to commence in 2005 - Q1 for completion in 2008 - Q1.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Below \$200 million

**Previous or planned panel consultation:** We plan to consult the Legislative Council Panel on Environmental Affairs on the proposed works in November 2004.

**Project Code and Title:** 7227CL – Tin Shui Wai development – village flood protection works for Sheung Cheung Wai, phase 2 – construction of interceptor drains

**Policy Bureau and Branch:** Environment, Transport and Works Bureau (Works Branch)

Works Department: Civil Engineering and Development Department

#### **Project Description:**

The proposed project is for the construction of the last phase of the flood protection works in Sheung Cheung Wai to further alleviate the flooding problems in Ping Shan North. The latest proposed scope of the project comprises construction of interceptor channels, drains and a box culvert to complete the flood protection scheme in Sheung Cheung Wai. The construction is tentatively scheduled to commence in 2005 - Q1 for completion in 2007 - Q1.

We have previously sought funding from the Finance Committee -

- (a) on 4 September 1986 for part-upgrading (as 7270CL) for construction of village flood protection works for Lo Uk Tsuen, Sik Kong Tsuen, Sik Kong Wai and Kiu Tau Wai together with improvements to the Ha Tsuen Stream and Hung Shui Kiu River;
- (b) on 8 December 1989 for part-upgrading (as 7338CL) for construction of two pumping stations for Sheung Cheung Wai and Ha Mei San Tsuen;
- (c) on 22 July 1996 for part-upgrading (as 7473CL) for construction of flood protection works for Ha Mei San Tsuen; and
- (d) on 21 June 2002 for part-upgrading (as 7698CL) for extension of the existing stormwater pumping station at Sheung Cheung Wai to provide additional discharge capacity.

PWSC endorsed the project at its meeting on 27 October 2004.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Below \$200 million

**Project Code and Title:** 7780TH – Retrofitting of noise barriers on Cheung Pei Shan Road, Tsuen Wan

**Policy Bureau and Branch:** Environment, Transport and Works Bureau (Environment Branch)

Works Department: Civil Engineering and Development Department

# **Project Description:**

The proposed project is for the construction of noise barriers and noise semi-enclosures along Cheung Pei Shan Road to reduce the traffic impact on nearby residents. The project scope comprises construction of approximately 870-metre long, six-metre high cantilevered noise barriers and 645-metre long noise semi-enclosures with overall height varying from 6.5 metres to 13 metres. The construction is tentatively scheduled to commence in 2005 - Q1 for completion in 2007 - Q3.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): \$200M - \$500M

**Previous or planned panel consultation:** We plan to consult the LegCo Panel on Environmental Affairs tentatively in December 2004.

**Previous or planned panel consultation:** In January 2004, we consulted the Panel on Education of the Legislative Council (Education Panel) on the mechanism for planning and provision of public sector school places and the School Building Programme. The Education Panel noted our plan to proceed with seeking funding approval of the Public Works Subcommittee for private independent schools which have already been allocated to sponsoring bodies, i.e. the category under which the proposed project falls.

**Project Code and Title:** 8046EF – Teaching complex at western campus, The Chinese University of Hong Kong

**Policy Bureau and Branch:** Education and Manpower Bureau

**Works Department:** University Grants Committee

#### **Project Description:**

The proposed project is for construction of an eight-storey teaching complex which will house some 50 rooms of various kinds (e.g. lecture halls, classrooms, research laboratories, seminar rooms, and function rooms) together with offices and necessary supporting and car parking facilities.
