2. <u>The Chairman</u> informed members that Mr James TO had advised her in writing that he would withdraw from the Subcommittee with effect from 14 April 2005.

Additional information to be sought from the Administration

- 4. <u>Members</u> deliberated on the need for the Administration to provide additional information in the form of Legislative Council (LegCo) Briefs to facilitate members' scrutiny work. While noting that Regulations made under section 3 of the United Nations Sanctions Ordinance (Cap. 537) (UNSO) were not subject to the approval or amendment by LegCo, <u>members</u> considered it necessary that the Administration should provide a LegCo Brief (or a sufficiently detailed paper comparable to a LegCo Brief) on each Regulation made under section 3 of UNSO to facilitate the study by LegCo. <u>Members</u> further agreed that the Administration should provide the requested paper/LegCo Brief on each Regulation to be made under section 3 of UNSO in future, as well as on the four Regulations gazetted since July 2004 (as set out in the Annex to LC Paper No. CB(1) 1195/04-05).
- 5. <u>Members</u> expressed concern about the long time gap (ranging from several months to over a year) before a Regulation was made and gazetted to give effect to the relevant resolutions passed by the United Nations Security Council (UNSC). Noting that the Regulations were made by the Chief Executive on the instructions from the Ministry of Foreign Affairs (MFA) and after consultation with the Executive Council, <u>members</u> would like to know the Administration's liaison, if any, with MFA regarding its instructions. After discussion, <u>members</u> agreed that the Administration should include the following information in the paper/LegCo Brief on the Regulations:
 - (a) the policy intent and background;

- (b) pertinent information on the relevant resolution(s) passed by UNSC, including the date on which the resolution was passed and the validity period of the resolution;
- (c) the date of receipt of the instruction of MFA;
- (d) the date of consultation with the Executive Council on the making of the Regulations;
- (e) in case there was a time gap between the adoption of the resolution and the gazettal of the relevant Regulation made under section 3 of UNSO, the reasons for such a time gap, the administrative and/or legal arrangements in place to give effect to the sanctions, measures to minimize such a time gap, and any attempt to liaise with MFA in case its instruction had not been received following the passing of the resolutions by UNSC; and
- (f) the formal document issued by the Chief Secretary for Administration to confirm the instructions of MFA (to be attached to the LegCo Brief/paper).

(*Post-meeting note*: With the agreement of the Chairman, the Clerk had conveyed the above request for additional information to the Administration on 18 April 2005, incorporating the suggestion of the Assistant Legal Adviser 2 that an explanatory note on each section of the Regulation be provided.)

6. <u>The Chairman</u> also asked the Clerk to check whether the Administration had provided any explanation in the past on the reasons for the time gap between the adoption of the resolution by UNSC and the making of the relevant Regulation under section 3 of UNSO.

Further views from Professor Yash GHAI

7. <u>Members</u> noted that Professor Yash GHAI of the Department of Law of the University of Hong Kong had indicated recently that he would try his best to provide by end April 2005 his further views on the legal and constitutional aspects of the issues arising from the implementation in Hong Kong of United Nations sanctions. The Secretariat would follow up with Professor GHAI in due course.
