# Legislative Council Subcommittee on West Kowloon Cultural District Development

## The Public Engagement Exercise

#### **Purpose**

This paper sets out the details of the public engagement exercise on the recommendations of the Consultative Committee (CC) on the Core Arts and Cultural Facilities of the West Kowloon Cultural District (WKCD) project.

## **Background**

- 2. Following the release of the recommendation report of the CC, the Government launched a three-month public engagement (PE) exercise in mid-September to explain the recommendations and to solicit views from the public.
- 3. The public engagement work was carried out extensively, both in terms of the number of people and variety of sectors involved. Members of the public have been encouraged to provide the Administration with their views by joining the on-line discussion forums, completing the wish cards available on-line or at the roving exhibitions held in venues of the Leisure and Cultural Services Department, community halls, Government offices and other places. They could also make their submissions in writing or express their views during the public forums.
- 4. Many Members of CC and its three Advisory Groups, namely the Financial Matters Advisory Group, Museums Advisory Group and Performing Arts and Tourism Advisory Group, have actively participated in the PE exercise in their personal capacity to explain to the public and the respective sectors the recommendations and the rationale behind them.

- For the whole exercise, the Government had 5. organised three public forums, a series of roving exhibitions held at 28 venues, and over 40 sector-specific briefings for, inter alia, Legislative Council, arts practitioners and administrators, the education sector, children and youth groups, policy think tanks, sectoral leaders, professional bodies, relevant district councils, chambers of commerce, as consul generals and international At the close of the PE exercise on organizations. 12 December, the Government received over 3 800 public Major details of the engagement work are at views. Annex A.
- 6. We have commissioned the Public Policy Research Institute (PPRI) of the Hong Kong Polytechnic University to be an independent consultant to collate and analyze public views received during the PE exercise. Their major tasks include conducting an analysis of public views obtained from public forums, sector-specific briefings, meetings, written submissions, on-line discussion board and wish cards, as well as conducting two telephone polls for the purpose of gauging and triangulating public views.
