I. Draft report on "Elderly in poverty"

[LC Paper No. CB(2)863/06-07(03)]

The Subcommittee deliberated (Index of proceedings attached at **Annex**).

- 2. <u>Members</u> considered the amendments to Chapters 3 and 4 of the draft report on elderly in poverty which had incorporated members' views made at the meeting on 8 March 2007, and deliberated on the recommendations in Chapter 5.
- 3. <u>The Chairman</u> said that the LegCo Secretariat would incorporate members' views and suggestions and revise the draft report accordingly. <u>Members</u> agreed that the amendments would be circulated to members for consideration. Unless substantial amendments were proposed by members, no further meeting would be held on the draft report.
- 4. At the suggestion of Ms Emily LAU, <u>members</u> agreed that the Subcommittee should discuss with the Commission on Poverty and the Administration the Subcommittee's draft report on elderly in poverty. The Subcommittee would then provide the report to the House Committee, and the Chairman would seek the agreement of the House Committee for allocating a debate slot to him under Rule 14A(h) of the House Rules for moving a motion on the report at a Council meeting.

II. Any other business

Proposed overseas duty visit

5. <u>Members</u> noted that the receiving parties in Spain proposed that the Subcommittee's visit be postponed to September 2007. <u>Members</u> considered that the alternative dates for the visit should be in late July or early September 2007, and asked the LegCo Secretariat to follow up with the receiving parties in the United Kingdom and Spain on the best timing for the visit.

Matters arising from the 2006 Population By-census Report

6. <u>Ms Emily LAU</u> said that at its meeting on 12 April 2007, the Panel on Financial Affairs received a briefing by the Administration on the summary results of the 2006 Population By-census. The Panel discussed, among others, the revised methodology for compiling the Gini Coefficient and noted that the Thematic Report on Household Income Distribution would be released by mid 2007. As the subject of Gini Coefficient was relevant to the study on combating poverty, she suggested that the Subcommittee should follow up the findings of the Thematic Report. <u>Members</u> agreed.
