I. Confirmation of minutes

[LC Paper No. CB(2)1632/06-07]

The minutes of the meeting held on 26 March 2007 were confirmed.

II. Post-secondary education for students with special educational needs under the new academic structure

[LC Paper No. CB(2)1612/06-07(01)]

2. The Subcommittee deliberated (proceedings of meeting at **Annex**).

Views of deputations

- 3. The Subcommittee received eight deputations to present views on the provisions of vocational training and post-secondary education for students with special education needs (SEN) under the new academic structure and continuing education for persons with disabilities (PWDs). The major views are as follows -
 - (a) students with SEN and PWDs should enjoy equal opportunities to access post-secondary education under the new academic structure and vocational training and continuing education;
 - (b) the Administration should establish a fund to provide financial assistance for tertiary institutions in procurement of equipment and services to support students with SEN in learning, and for students with SEN, in the form of fee subsidies or remission, for example, in pursuit of post-secondary and continuing education;
 - (c) the Administration should formulate policies to help teachers identify students with specific learning difficulties (SpLD students) and provide teachers with relevant professional training on SpLD. It should provide SpLD students with appropriate curriculum, examination arrangements and assessment modulations;
 - (d) a task group should be established to oversee and coordinate the provision of support and facilities for students with SEN enrolled in Hong Kong Institute of Vocational Education (IVE) and the University Grants Committee (UGC)-funded institutions. There should be a dedicated officer in each institute to coordinate support to students with SEN, assist teachers in understanding their needs and advise teachers on the appropriate teaching skills;
 - (e) Vocational Training Council (VTC) and the UGC-funded institutions should exercise flexibility and adopt affirmative discrimination in considering applications for admission from students with SEN, such as exempting certain subjects for students with specific disabilities and allowing a longer period of time to complete the study;
 - (f) VTC should establish a support office in each institute under IVE and provide vocational assessment service in each Skills Centre;
 - (g) more community colleges should be established to provide lifelong learning opportunities for persons with intellectual disabilities; and

(h) the scope of services and variety of training programmes provided by day activity centres for PWDs should be enriched with more social and recreational activities.

Views of members

- 4. <u>Members</u> considered that like other students, students with SEN should have equal right and access to post-secondary education and continuing education. They were disappointed with the current provision of post-secondary education and continuing education opportunities for students with SEN. <u>Members</u> urged the Administration to formulate policies to encourage enrolment of students with SEN in post-secondary and the UGC-funded institutions. Members made the following suggestions -
 - (a) the Administration should formulate policies and devise special measures to encourage IVE and the UGC-funded institutions to admit students with SEN. IVE and the UGC-funded institutions should set aside certain places for students with SEN. The proposal of exempting students with SEN from fulfilling certain entry requirements should be actively considered;
 - (b) a task group should be established to coordinate the provision of support for students with SEN in post-secondary institutions;
 - (c) a dedicated fund should be set up to assist students with SEN in pursuit of vocational training, post-secondary and continuing education;
 - (d) the Administration needed to coordinate efforts from various fronts to work out innovative approach to assist students with SEN to pursue post-secondary and continuing education. Participation of parents, NGOs and post-secondary institutions would be necessary; and
 - (e) the Administration should be more proactive in the provision of resources and support to facilitate the operation of community colleges.
- 5. <u>Members</u> requested the Administration to provide information on the enrolment of students with SEN in each of the UGC-funded institutions. VTC was requested to provide the following information -
 - (a) the programme capacity of IVE and student enrollment in individual programmes in the past 10 years. The information should include the number of applications received, applicants

- shortlist for interviews, successful applications, students enrolled, students withdrawn from the programmes and students graduated;
- (b) resources allocated to the Skills Centres for running programmes and the programme fees for the past 10 years; and
- (c) support provided to students with SEN before and after the establishment of the Task Force on Provision of Services for Students with SEN Group in 2006.
- 6. In response to the Chairman, the Administration agreed to provide the requested information and a written response on members' views and suggestions in two months.

7. <u>Members</u> noted the schedule of meetings for May to July 2007 tabled at the meeting. <u>The Chairman</u> suggested and members agreed to discuss the Ombudsman's recommendations on assessment of children with specific learning difficulties at the next meeting scheduled for 28 May 2007.

[*Post-meeting note*: The meetings for the months of June and July 2007 were subsequently re-scheduled for 22 June and 6 July 2007 respectively.]

		Mr CHEUNG's view that like the provision of an alternative Chinese curriculum for ethnic minority students to facilitate their access to university education, the Admin should coordinate with the UGC-funded institutions and VTC to formulate policies and arrangements to enhance enrolment of students with SEN.
