#### T. **Election of Chairman**

Mr LEE Cheuk-yan, the member who had the highest precedence in the Council among all members of the Subcommittee, presided over the election of the Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

- 3. The Subcommittee deliberated (Index of proceedings attached at Appendix).
- 4. Referring to the motion on reducing the duty on ultra low sulphur diesel (ULSD) moved by Hon Miriam LAU and as amended by Hon Ronny TONG which was carried at the Council meeting on 3 November 2004, members requested the Administration to expeditiously review the current rate of duty on ULSD and report the outcome in three months' time. Members further suggested that the Administration should also examine the high local pump prices during the review. In response, the Administration said that it had carefully reviewed the prevailing circumstances and the duty rate. Taking into account the fiscal condition, the overall economic conditions and the pressure faced by the transport industry, the Administration proposed to further extend the current concessionary duty for another year. The Administration said that as the motion was only passed on 3 November 2004, the Administration would need to study

the motion and was therefore not in a position to give a firm undertaking at this moment. It would nevertheless revert to Members on its response in due course.

- 5. On the mechanism for setting the duty rate on ULSD, <u>members</u> asked whether the Administration would consider making the existing concessionary duty rate at \$1.11 per litre a permanent arrangement because this duty rate had already been extended on five occasions in the past six years. In response, <u>the Administration</u> indicated that at this stage, it did not contemplate a permanent extension and it remained the Administration's long-term intention to re-align the duty rate to \$2.89 per litre in due course when the economy improved. <u>Members</u> further urged the Administration to consider stipulating a reasonable duty rate in the principal ordinance instead of moving a motion every now and then to seek Members' approval to extend the so-called concessionary rate.
- 6. <u>The Administration</u> undertook to relay members' comments and concerns on various policy issues to the relevant policy bureaux for consideration.
- 7. <u>Members</u> did not raise any query on the proposed resolution. They also agreed that the Administration should give fresh notice to move the proposed resolution as soon as possible.

(post-meeting note: The Administration subsequently advised that it would give notice to move the proposed resolution at the Council meeting on 1 December 2004)

8. <u>The Chairman</u> concluded that the Subcommittee had completed scrutiny of the proposed resolution and would report to the House Committee.

(post-meeting note: The Subcommittee would report to the House Committee on 12 November 2004)
