- 2. <u>The Chairman</u> drew members' attention to the letter dated 25 August 2005 from New Lantao Bus Co. (1973) Ltd. (NLB) (LC Paper No. CB(1)2238/04-05(01) which was issued under confidential cover for the reference of the Subcommittee's members only as the letter contained information relating to the detailed commercial discussions on Ngong Ping visit combo packages among NLB, MTR Corporation Limited (MTRCL) and Skyrail-ITM (Hong Kong) Limited (Skyrail).

Clause-by-clause examination of the proposed Tung Chung Cable Car Bylaw

(LC Paper No. CB(1)2236/04-05(01) - Proposed resolution under Section 22 of the Tung Chung Cable Car Ordinance (Cap. 577) moved by the Secretary for Economic Development and Labour)

- 4. <u>The Subcommittee</u> commenced clause-by-clause examination of the proposed Tung Chung Cable Car Bylaw.
- 5. <u>Members</u> noted that according to Skyrail's current planning, the journeys of the round-trip ticket for Ngong Ping 360 would have to be taken within the same day. <u>Members</u> pointed out that there were passengers who would choose to reside overnight at Ngong Ping. Skyrail took note of this point and would consider if the validity for the round-trip ticket could be extended for these passengers.
- 6. <u>The Administration</u> and <u>MTRCL/Skyrail</u> were requested to provide the following information –

The Administration

- (a) To continue to monitor the discussion on cooperative arrangements between Skyrail and New Lantao Bus Co. (1973) Ltd. and report the progress to the Subcommittee in due course;
- (b) To provide the estimated patronage, in terms of passenger trips, of different types of transport modes after the commissioning of the Tung Chung Cable Car System and the completion of the tourism development in Ngong Ping. Where available, the existing patronage situation should also be provided;

MTRCL/Skyrail

- (c) Regarding section 11 on revision of fares of the draft Bylaw, to consider the practical means of giving advance notice of any fare adjustment to the public;
- (d) Regarding section 12 on "Tickets contain no warranty or acceptance of liability" of the draft Bylaw, to consider revising the section to duly safeguard consumers' interest with reference to the relevant practices/statutory provisions of similar overseas facilities;
- (e) Regarding sections 14 to 16, to advise the Subcommittee of the intended approach for handling cases such as unintentional entry and travel without ticket by children; and
- (f) To advise the Subcommittee of the policies in respect of the offer of concessionary fares and the refund and exchange of tickets.
