Clause by clause examination of the subsidiary legislation

- 2. The Subcommittee completed clause by clause examination of
 - (a) Administration of Estates by Consular Officers Ordinance (Amendment of Schedule) Order 2005 (L.N. 53);
 - (b) Consular Conventions (Application of Section 3) Order 2005 (L.N. 54);

- (c) Consular Relations (Additional Privileges and Immunities) (Vietnam) Order (L.N. 55);
- (d) Administration of Estates by Consular Officers Ordinance (Amendment of Schedule) (No. 2) Order 2005 (L.N. 56); and
- (e) Consular Conventions (Application of Section 3) (No. 2) Order 2005 (L.N. 57).
- 3. <u>The Administration</u> was requested to respond/give consideration to the following issues raised by Mr James TO
 - (a) in relation to inviolability of consular premises and residences of consular officers, to provide the internal guidelines governing the actions to be taken by law enforcement agencies in Hong Kong under special or emergency situations which necessitated entry into the premises or residences;
 - (b) to consider reviewing the scope of the powers of consular officers in relation to property in Hong Kong of deceased persons under section 3 of the Consular Conventions Ordinance (Cap. 267). Mr TO pointed out that an executor who was resident in Hong Kong might not be able or might not want to be present in Hong Kong to dispose of the property of the deceased: and
 - (c) the Government of the Hong Kong Special Administrative Region should reflect to the Government of the People's Republic of China that caution should be exercised in concluding international agreements on grant of additional privileges and immunities to consular officers of certain countries.
