Panel on Administration of Justice and Legal Services Meeting on 24 January 2005

Manpower position of drafting counsel in the Department of Justice

At the meeting of the Panel on 24 January 2005, Members of the Panel requested information relating to the in-house legislative drafting course organized by the Law Drafting Division (LDD) and the overseas legislative drafting course offered by RIPA International, London.

In-house Legislative Drafting Programmes

Three courses have been organized since October 1999. Eighteen draftsmen at Senior Government Counsel (SGC) or Government

Counsel (GC) rank were trained. The duration of the first two courses were 21 weeks and the cost was \$735,000 apiece. The third course lasted for 24 weeks and costed \$840,000.

An outline of the third course is annexed to Appendix to my letter to you dated 30 November 2004 on the subject. The trainer is Dr. Duncan Berry. A brief C.V. of him is attached.

Legislative Drafting Course in London

LDD had nominated counsel at SGC/GC rank to attend the Legislative Drafting Course organised by RIPA International (formerly known as the Royal Institute of Public Administration). The last 2 nominated officers attended the course in 1997 and 1998. The duration of the 1997 course was 10 weeks and the cost was \$150,000. The 1998 course lasted for 9 weeks and costed \$153,500. The costs covered tuition fee, air tickets, accommodation and subsistence allowances and study grant.

RIPA International is still offering the course. A copy of the course outline is attached. If we nominate an officer to attend the course commencing in September 2005, the estimated cost for the 9-week course is \$175,000.

Comparison

The local course is much longer and, accordingly, more comprehensive and elaborate. It is also obviously more cost-effective. We paid \$5,833 for every week of training for one counsel (\$840,000÷24 weeks÷6 persons). The latest London course we attended costed \$17,000 (\$153,500÷9 weeks).

The class size of the London course varied from 10 to 15, while the class size of the local course was fixed at 6. Smaller class means the trainer was able to give more attention to the classworks of each trainee. Another problem with the London course is it was often attended by people with little or no practical experience in legislative drafting. Advanced drafting skills might therefore not always be taught.

We therefore consider the local course a preferable option. However, we do not rule out the possibility of making nomination for suitable overseas training in legislative drafting.
