Release of Statistics on Private Housing Supply in Primary Market

Purpose

This paper informs Members of the progress of the Administration's policy initiative to release statistics on private housing supply in the primary market.

Background

- 2. One of the Administration's new initiatives in the 2004 Policy Address is to compile comprehensive housing supply statistics. A comprehensive database has been established accordingly to monitor the private housing supply situation and is being updated regularly in consultation with the government departments concerned. Some of the statistics have been announced on an *ad hoc* basis.
- 3. To further enhance the transparency of the Administration's database and to enable the public to have a clearer picture of the flat supply situation based on factual data, the Housing, Planning and Lands Bureau (HPLB) will start to release, on a quarterly basis via its website, statistics on private housing supply in the primary market together with detailed explanatory notes.

Statistics Released

- 4. The statistics available on the website cover the following types of information:
 - (a) yearly breakdown of the number of private residential units in respect of which **construction commenced** in the past few years;

- (b) yearly breakdown of the number of private residential units **completed** in the past few years; and
- (c) the number of **unsold** units in completed private residential projects and the number of units still **under construction** after accounting for those which have been sold by pre-sale, as known at the end of the quarter concerned.
- 5. In addition, more detailed breakdowns of the data are provided where appropriate. The public may view the full set of statistics at www.hplb.gov.hk.
- 6. It should be noted that the statistics, which show a snapshot of the supply situation at the end of the respective quarter, will change over time and do not constitute a forecast.

Comparison with Some Departments' Statistics

7. Some government departments also make available to the public periodically related statistics on private housing supply. As these statistics are compiled for different purposes and are based on different parameters, they may not be directly comparable or identical to the statistics released on HPLB's website. The main differences between the data sets are outlined in the comparison chart on HPLB's website explaining the parameters of the various data sets.

Improving Transparency and Interpretation of Data

8. Releasing the above-mentioned statistics on a quarterly basis gives a time-series picture of the supply situation in the primary market as seen at different points in time. Members of the public can thus have a useful source of reference, which they would find useful as they make their own assessment on the supply situation of the private housing market.
